IMechE Nominations Committee - report to Trustee Board and Council

1. Summary of recent tasks completed

1.1 Nominations process for the 2024 Corporate Elections

The Nominations Committee met several times to discuss the process for the 2024 Corporate Elections.

There are four vacancies to be filled on the Trustee Board. NomCo duly prepared the relevant documentation and advertised the opportunities to all eligible members.

There were 32 applications from 21 applicants.

At the end of the NomCo review process and interviews, NomCo presented its conclusions to the Trustee Board. This is in accordance with its Terms of Reference and other guidance documents, viz. NomCo shall consult the Trustee Board on the selected nominees; the Trustee Board's views, if any, would be considered by NomCo before its list of selected nominees is issued.

The Trustee Board accepted and affirmed the NomCo nominations. These names were published on the IMechE website by the IMechE's Governance team in preparation for the Ordinary Meeting on 5 March 2024.

NomCo will be reviewing the 2024 election process and will look to make adjustments in preparation for the 2025 Corporate Elections. It is NomCo's objective to present a diverse list of names to the electorate, and your support to achieve this each year is appreciated.

1.2 Trustee Board - Ordinary Member co-opt (Property)

NomCo were delighted to receive 8 applications for this role. Richard Guest (NomCo Vice - Chair) took the lead role in this NomCo task.
